By joining and participating in the SIRC Forum, you (hereafter "you", "Member" or "Members") agree and acknowledge that you have read, understood, and will follow all rules and guidelines outlined in this Terms of use and privacy policy (this "Agreement"). This Terms of Use and Privacy Policy describe membership in and use of information in the Sport Information Resource Centre ("SIRC") website and the SIRC Forum.

The SIRC Forum is an interactive, online platform that unites Canada's communities of sport researchers and practitioners to advance the Canadian sport system. As a sport researcher (including graduate students, research associates, postdoctoral fellows, and professors) or sport practitioner (ranging from athletes, coaches, and officials to administrators and policymakers), the SIRC Forum is a place for you to ask and answer questions, share resources and findings, discuss trending topics or issues, and connect with potential partners or collaborators.
