Candidates must submit an Expression of Interest (EOI) for **only one (1)** position on the Board of Directors (forms can be found [HERE](#)). To be eligible, candidates must submit a **COMPLETE** EOI application package consisting of the following five (5) mandatory items:

- **Required Documents:**
  1. **Appendix A** – Expression of Interest Form
  2. **Appendix B** – Skills and Competency Form
  3. **Appendix C** – Nomination Form (Note: Voting Members can nominate more than one candidate)
  4. **Brief résumé** (maximum two pages) outlining your soccer/sporting and professional/business background
  5. **References or endorsements** from at least **two (2)** individuals (not related to you) who have known you for a minimum of **five (5) years**
- **Additional Documents:**
  6. Self-Identification Form (*voluntary*)
  7. Police Record Check – Facilitated by Ontario Soccer, if required

**Submission Deadline:** Submitted electronically on or before **Saturday, July 19, 2025.**

A confirmation email will be sent in response to confirm that a candidate's EOI package has been received and is complete. Please note that late applications **will not be considered**.
